Notes for completing the medical / religious diet school meals request form.

Please complete the Special Diet Request Form if your child has: -

- Allergy or intolerance to a food(s)
- Need to follow a special diet for another medical reason (e.g., Diabetes, Autism)
- For Religious/Cultural purposes (e.g., Halal, Hindu)

Allergies, intolerances, and medical reasons require a Health Professional or Social Workers details and signature; *Health Professional (e.g., Doctor, School Nurse, Practice Nurse, Dietitian or Health Visitor) or Social Worker before a special diet can be provided.

Once the form has been completed, please return to the address at the bottom of the form; and keep a copy for your records. Once we have received the form, you will either receive a special menu for your child by post / email or be contacted by phone to discuss your child's special diet requirements and then a menu will be sent out to you.

Please allow 15 school days for your menu to arrive **(Please note at certain times of the year this maybe longer due to an increase in the number of diets being requested).**

Once you receive your child's menu, we ask that you contact us to confirm that you are happy with the menu and discuss a start date. Your child's school cook will also get a copy of the menu and once we have discussed the menu and start date, we will inform your child's school cook.

To protect the health of your child until you have confirmed the start date for your child's special menu, or you have completed a disclaimer form (see next page for more information on the disclaimer form), your child should bring a packed lunch provided from home.

Questions & Answers

Q. My child is following a vegetarian, vegan or pescatarian diet, do I need to complete the special diet form?

A. If your child is following a lifestyle choice diet and does not have a food allergy or intolerance, please do not complete this form as these lifestyle choices can be catered for in the standard menu.

Q. Why does a Health Professional need to sign the registration form?

A. A signature from a Health Professional shows us that the diet has been medically agreed and will not cause any life threatening or unnecessary restriction to the child to protect their health.

This is also required to eliminate any requests that may come from child disliking certain foods or fussy eaters as this would provide as extra volume of work that would not be manageable for the school cooks.

Q. I cannot get the registration form signed by a Health Professional.

A. We will also accept a copy of a letter from a Health Professional stating the food(s) that must be avoided or the type of special diet needed (e.g., puree/ soft options) if it is less than 6 months old.

Q. Will my Doctor or Health Professional charge me?

A. Your doctor or other Health Professional should not charge you to sign this form as the dietitian who completes the special menu works for the NHS.

Q. My child can manage their special diet without needing a special menu. Do I still need to complete a Disclaimer Form?

A. We understand that some children can manage their dietary requirement without following a special menu. If this is the case there is a disclaimer form you can complete, which is available from your school office. By completing this form, it allows the catering team to be aware that your child is following a specialist diet. (Please note school menus cannot be altered with this option).
